



## **Music Department Dress Code and Expectations**

### **Dress Code**

#### **Sunday Services**

##### **Ladies**

- Skirts should be BELOW the knee when sitting and standing.
- Clothing should not be too form fitting.
- Make-up should be minimal and of nude/skin tone color.
- Sleeve length should be no shorter than the middle of the upper arm
- Necklines should be no lower than 3 finger breadths below the collar bone.
- NO colored fingernail/toenail polish. French tip/nude/clear colors are acceptable.
- Hair can be up or down but if you have cut ends, we ask that you wear it up or curled.
- Because of the bright lights shining on the stage, please wear a slip (daylight test).

##### **Gentlemen**

- Clothing should not be form fitting.
- Sunday's dress is a long sleeve button down shirt with a tie.
- Jackets are preferred excluding musicians due to movement.
- Hair must be fixed and groomed, and not longer than your shirt collar in the back.

##### **EVERYONE**

- No jewelry (Necklaces, earrings, etc.). Wedding/engagement rings, promise rings, and graduation rings are acceptable.
- No jeans
- No sneakers

#### **Wednesday Services**

- Business casual dress is acceptable. Gentlemen may wear khakis and a button up.
- No ties are required.

#### **Additional Expectations**

- Both musicians and singers should listen to and know their music BEFORE rehearsal.
- Booth, vocalists, and musicians should arrive for rehearsal early enough that the whole team can be prepared to start at the determined time.

## **First Pentecostal Church Social Media Policy:**

We believe it is in the best interest of First Pentecostal Church to be aware of and participate in the positive benefits of social media while being aware of potential areas of concern.

The following guidelines aim to provide you helpful, practical advice and also to protect both you and First Pentecostal Church.

### **Guidelines:**

1. All employees and volunteers are personally responsible for the content that they publish online. Be mindful that what you publish on a social media network, may be viewed not only by the intended recipient but may be shared by that recipient or may be inadvertently viewed by others. Consider all content you post as if it were public.
2. Your online behavior should reflect the same standard, if not greater standards of holiness, honesty, respect and consideration for God and First Pentecostal Church.
3. Remember your association and responsibility with First Pentecostal Church in online social environments. Whether or not you identify yourself as a First Pentecostal Church employee or volunteer, ensure your profile and related content is consistent with how you wish to present yourself with church members and the community.
4. Concerns that you may have with church policies, church members or the community should not be aired publicly on social networking sites. Refrain from any online postings that are derogatory toward First Pentecostal Church, other employees, members, guests or others.
